Councillor Edmondson made the Parish Council aware that he is related to the applicant of a current planning application (SL/2014/0521).

752 PUBLIC PARTICIPATION AND REPORTS FROM COUNCILLORS ETC

Patrick Elliott reported that he had received a letter from the church diocese stating that they were planning on selling the field behind high garth for building land. The general feeling amongst local residents isn't good. Mr Elliott wanted to know the pc views. The chair pointed that the Parish Council objected when it was earmarked as local development framework land. Cllr Carson suggested that an alternative could be found for SLDC. It was agreed that the Parish Council were still against the idea of housing development. Cllr Willis stated that nobody had been in touch with South Lakeland District Council regarding planning etc. Cllr Campbell asked if there was a way of mitigating the effect on the village by asking SLDC for a development brief which may deter potential buyers.

Councillor Willis reported that cyclists are having problems on roundabout. It isn't seen as a priority as they don't want to encourage cyclists to go into the bends on the roundabout. Also reports that wagons are a problem parking outside the fish and chip shop. Janet will look further into it.

Speed data has arrived. Mount pleasant from school: nobody exceed the speed limit and the average speed was 13mph. Main street – average speed was 15/16 mph. 23 exceeded the limit in the week. Mean speed 18mph. 23 vehicles throughout the whole area were speeding. Members of the public still want a 20mph speed limit. Janet pointed out that money can be spent on 20 is plenty but people would still only do the speeds they are doing.

It was also pointed out that land bordering onto the field haven't had notification. One member of the public pointed out that there are already 5 properties for sale in the village. There was also a worry that if this was passed then the knock on effect could be future building.
