888 PUBLIC PARTICIPATION AND REPORTS FROM COUNCILLORS ETC

Janet Willis update on highways:

- Spark Bridge the north end has been done and south end is on for next financial year.
- The footpath on Greenodd has been brought up to be addressed by highways. Sheila raised the issue with lack of a barrier on the road next to the road side at Rosside.
- Problem with drainage in Ellis Wood and Penny bridge. The two may be connected. Brian Campbell queried if this is a council sewer. Janet Willis responded that it was as far as she was aware.
- Had a meeting with Victoria Upton and are hoping to get the signage updated for heavy goods vehicles for the road near middle Mansrigg.
- White lines have gone in at Penny Bridge school and are been finished when the weather has got better.
- Janet Willis got a response from Mr Reade from Highways about accidents on the A590 at Mansrigg and he has responded to say that he will get a full report by the middle of March.
- Parish Council approached Bill Thompson about water running off his land.
- Ken Atkinson concerned that the crake might flood around his land.

Brian Campbell asking if the information as reported above is available for public access. Janet Willis responded saying it is information as part of the Highways Working Group.

Brian Campbell raising an issue with Janet Willis about freezing and frost around the local roads.

Karen Hadwin raised an issue around the Arrad Foot junction and people cutting down the incorrect side of the bollard. Asked Counsellor Willis to raise the issue with highways.

On behalf of John Silcock, that the work that has been done has gone over budget and that there has been an issue with how the work has been undertaken as part of how the parish council has done. Confusion over what the best way to proceed and what has been agreed or to be agreed by the Council and John Silcock.
