875 PUBLIC PARTICIPATION AND REPORTS FROM COUNCILLORS ETC

Councillor Janet Willis Some funding for Penny Bridge Dip.

Councillor Butcher commented on the flooding, raised an issue around the drainage in front of Henry Armor shop and has engaged in discussing with the highways. Ken Atkinson not taking it as a serious issue.

Councillor Janet Willis commenting that there are bigger issues elsewhere at the moment so we have to be understanding that these aren't president circumstances.

PCSO there have been some wheels stolen from the garage in Greenodd. They got over the fence.

876 DISCUSSION ON TRAINING FOR NEW PARISH CLERK

Zara has brought up the opportunity to do a Clerk Induction that has been put up on the Training section of their website. Anne Burrow brought up approval, Jane Carson Seconded. To inform the Parish Council when dates are available.

877 FEEDBACK FROM HIGHWAYS ABOUT PARKING BROUGHTON BECK MILL ROOMS

The verges and hedges have now been cut back by Silcock Gardening Service. Howard Graves feels this will of helped greatly. There is an issue around being careful where to leave the vehicles rather than leave them in front of peoples drives.

878 **PLANNING**

Denise Edwards brought up an issue around receiving the Weekly Planning list, Zara Myers reassured that the intention was that the weekly list was to be forwarded. Apologies made that this had not happened promptly and will be addressed.

Jane Carson brought up an issue around opening the weekly list and feels there should be an easier way to reference the planning application. Councillor Campbell stated that he felt that it's a minor issue and commented that it seems to be simple enough at the moment.

 - Planning Application for Arrad Foot Farm- requesting planning. Reviewing of the planning application. Objections based on the previous letter sent regarding the condition of the access to the farm.

Councillor Campbell confirms the objection from the Parish Council.

Conclusion is that the Parish Council will send that same letter as previous, Zara Myers to take into hand.

- B No objections to Two Storey Rear Extention.
- C Councillor Butcher asked about feedback from the wooden structure in Newlands wood. Councillor Campbell believes that because it is registered woodland that a structure of that type is agreeable to construct.
- D Arrad Foot balconies had a problem with complaints from the residents. Anne Burrow explained that they have had issues with wood burning however, they have now gained permission for that. There was also an issue around heavy lorries going up and down the road. However, Anne Burrow's

Zara Myers ENMO Parish Council believed that this happens rarely. Also, as you go into the entry, in the past there was a curb, however, it has now deteriorated. It has been suggested to them that this be replaced so water doesn't rush into the road which could potentially cause an ice risk.

879 CRAKE VLLEY PRESENTATION REPORT

A Peter Taylor reported that the meeting was very informative. The main things that they brought up were the Crake Valley get £1.2M. They work in partnership with volunteers. They have been working with John Ruskin school with their GCSE science projects. They focus on 4 areas, Riverfly, Spawning gravels (monitoring the contours in the rivers), Phosphate sampling and Electro fishing (monitoring the number of fish in the valleys).

Councillor Campbell asked for Zara Myers to attach the Crake Valley Partnership report to the minutes when they are emailed out.

881 CALC REPORT ON THE ELECTORAL REVIEW OF SOUTH LAKELAND

Howard Graves: The first consultation period is about to finish for the Electoral review. They would like some feedback as to if the wards are in the correct places and any other issues can be raised. Their aim is to connect councillors to the electoral numbers and to establish if the wards are placed correctly. After the 11th January there is a consultation with some Draft Recommendations. In August they will publish final recommendations that will be part of the 2018 elections. Councillor Campbell asking if this is something that we respond to individually which was confirmed by Howard Graves.

Discussion around if we are keeping the rates or putting them up. Jane Carson commented that there is an issue because we are not sure what the rate pairs are. The rate pairs in the parish will of changed since last year.

The funding is unlikely to come from SLDC now because of the funding cuts. Councillor Butcher commented that the parish should be getting extra funding from housing development however Janet Willis commented that we don't have many developments in the area.
