- b) Mansriggs & Osmotherley Annual Parish Meeting held 17<sup>th</sup> May 2022 – Land at Tarn Close, Rosside -resolution passed for the administration of this land can now fall under the combined Parish of Egton with Newland, Mansriggs & Osmotherley Parish Council.

**The Parish Council resolved to accept the resolution passed on 17<sup>th</sup> May 2022 for the administration of the land at Tarn Close to be administered under the combined Parish Council ENMO**

- c) Parish Council to approve a request for SLDC to amend the Grouping order so that the assets of the former PCs of Egton with Newland and Mansriggs and Osmotherley become assets of the common parish council.

To consider making an application to SLDC to amend the 2003 Grouping Order so that the assets of the original parishes are vested in the common council created in 2003.

**Chairman reported that SLDC had confirmed that it is possible to modify the grouping order and that for the land/assets administered under Egton Parish meeting and Mansriggs and Osmotherley Parish meeting to be combined as assets of ENMO Parish Council.**

**Parish Council to write to the garage owners at Tarn Close to charge rent and also clarify that they have public liability insurance.**

**The Parish Council agreed to keep the two existing trustees and in addition appointment three new trustees being the Councillors for Mansriggs & Osmotherley.**
