1525: Apologies: from Cllr. Tony Mayo received in advance of the meeting.

1526: Adoption of minutes from 9th May 2023 meeting to be signed by Chairman.

1529: Public participation / report from Westmorland and Furness Councillor

Westmorland and Furness Councillor was not present at the meeting. Chairman to contact regarding his presence at future Parish Council meetings.

Residents from Tarn Close, Rosside who were present at the meeting expressed concern over the trees at Tarn Close. The Chairman reported that Mike Smith (local forester) would be undertaking a survey of these trees and possible replacements. No action would be taken without consultation with the residents. Site meeting to be arranged.

Well at Rosside. The restoration of a well was mentioned and the Council indicated that they would be keen to help with this and to provide some funding.

The Parish Council will be charging for ground rent to the owners of the garages. A question was asked as to how the Council have calculated the amount to charge, and this was after taking advice from a local valuer. Formal agreements will be prepared for the tenants to sign.

One resident present was concerned about the ongoing situation/ repair to the bus shelter at Penny Bridge (Clerk's report item i). The Chairman reported that the roof will be replaced with a translucent covering and that the interior to be painted. There is an issue with overgrown ivy which needs to be cut back however permission is required from the relative landowner.

Visibility at the bus stop both from passengers and the bus drivers view is poor and needs to be addressed.

Greenodd Village Hall to hold a committee meeting next week whereby they will vote in favour of supporting the use of the hall in an emergency.

Cllr. Hartley reported that the WI are willing to provide support in the event of an emergency.

An electrician has visited the village hall and will provide a quote for the installation of a generator access point.

Clerk to advise ENW of our intention to apply for funding.

It was resolved that a working party comprising of Cllr. Hind, Cllr. Campbell and Cllr. Douglas meet prior to the next Parish Council meeting on 5th September 2023 to consult and prepare a draft document.

l) Sedbergh School working party reports- successful days with the bus shelter at Greenodd being repainted, bus stop and picnic benches in Spark Bridge being cleaned. Clerk to write to the Headmaster to thank him and his pupils for their help.
